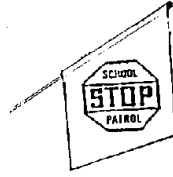

## ATTENTION!

Applications for reservations for 2012 Legionville School Safety Patrol Training Center at Brainerd, Minnesota are now being accepted by The American Legion, Department of Minnesota, 20 W. 12<sup>th</sup> St., Room 300A, St. Paul, Minnesota 55155-2000.

The fee is **\$225.00** per trainee and **MUST** accompany the “Request for Reservation” form. **PLEASE MAKE CHECKS PAYABLE TO LEGIONVILLE.** Your “Request for Reservation” must also designate the number of boys and the number of girls for whom fees are being remitted, as well as the sessions requested. (Please make sure an alternate session is noted on the registration form). It is necessary that we receive this information in order to make a reservation for you. All eight sessions will be co-ed again this year.

Kindly fill in the name of the school(s) from which you will be sponsoring patrol members.

**It is NOT necessary that we have the names of the school patrol members at this time. The purpose of the application is to insure that a place will be reserved for your youngster(s) in the session(s) you select. The name(s) can be supplied after we have acknowledged receipt of your “Request for Reservation” form and fee(s), and have sent you the registration cards.**

Patrol members who will be 10 years old before September 1<sup>st</sup> and not older than 13 years will be eligible to attend the training center program. **Exceptions are allowed but should be cleared ahead of time through our St. Paul office**

Please note that the above policy derives from the 1990 Minnesota Statutes, Chapter 120.06, Subdivision (1).

**Please read the enclosed brochure and reservation form carefully.** Enclosed are “Request for Reservation” forms in duplicate. Only the ORIGINAL needs to be sent with your registration fee(s). Helpful information will be sent to the person that you name to act as Legionville Chairman for your organization.
